FEMA does not provide help for businesses. FEMA also does NOT pay for trees that fall and hit the ground. FEMA refers businesses to the Small Business Administration.

The SBA provides for loans to help businesses which will not help our situation.

Auto Owners paid \$22,925.98 for tree removal along the front wall and front wall repair.

Note: Insurance does not pay for trees that fall on the ground.

The fence and the culvert were not covered on our insurance policy.

I will be scheduling an appointment with Cohen Bailey to submit actual invoices for repairs to wall and tree removal to see if we can collect more money from the insurance company and also to add the fence and culvert to our policy going forward.

The monthly schedule of expenses by board member was distributed to each board member for their review. Also, they were asked to decide what their expenses should be for 2025 so we can review at the December board meeting. A budget will then be prepared and reviewed at the January 2025 board meeting.

We will be getting several estimates for repair.
